# Glencoe Conditions of Hire



- 1) Period of Hire will be from 3p.m on day of arrival until 9am on day of departure.  
(At certain times of the year the above times may be varied by arrangement with the proprietors)  
Luggage may be left and collected outside of the above times by arrangements with the proprietors.
- 2) All persons sleeping in the flats must be named on the booking form. The number of persons per flat must not exceed the number for whom beds have been provided. Should any person be staying for only part of the hire period they must also be named on the booking form or notified to the proprietors. This is a Fire Risk requirement!
- 3) Cots and High Chairs, if requested on the booking form will be supplied free of charge. However, should our stock be exhausted we will "hire in" if requested but the charge would then be levied
- 4) Flats are given a final cleaning before the Hire period commences. Any shortages, breakage's damage or maintenance requirements must be notified to the proprietors as soon as possible. Hirers are required to leave the Flat clean and tidy upon vacation.
- 5) The Flats have been modernised and fireproofing and sound insulation materials have been included in the structure. In the interests of other occupants noise must be kept to a reasonable level and excess noise must not be permitted between 11 pm and 7 am Should the fire alarms sound all occupants must vacate the flats and not return until told it is safe to do so.
- 6) Hirers may use a parking space in the Glencoe Holiday Flats car park, but do so at the own risk.
- 7) The Proprietors maintain their Flats to a high standard and take all reasonable care to prevent any contingencies arising which may affect the hire period of the flats. However, the Proprietors cannot accept liability for any contingency which may arise, however caused which is beyond their control and may affect the period of hire.
- 8) For the comfort of our guests we are a NON-SMOKING ESTABLISHMENT and would appreciate your cooperation.
